Thank you for your interest in owning a Habitat home. Attached you will find an ***Application for Housing***.

Families interested in applying for a Habitat for Humanity home must:

- Have a need for adequate, affordable shelter.
- Have lived in St. Joseph for at least one year.
- Be willing to partner with Habitat throughout the family selection process & construction of the Habitat home.
- Be a permanent legal resident of the United States for at least 5 years before applying.
- *Be willing to obtain a background check from the Missouri State Hwy Patrol (\$20 fee).

If you feel your family meets all the selection criteria and you want to apply for a Habitat home, complete and sign the ***Application for Housing***. Return the application to the Habitat office along with

- proof of income** (pay stubs, etc.)
- proof of permanent residency** (see back for list of acceptable documents).

Our Family Selection Committee will review all applications, request verifications, and ultimately will recommend to our Board of Directors those families that they feel would best meet all of the qualifications in order to become successful Habitat homeowners.

NOTE: Forms must be filled out completely. If you need help filling out the application or forms, please call the Habitat office (279-2552) to make arrangements to meet with a volunteer from our Family Selection Committee to help you with this process.
